

# Mercedes-Benz StarRewards Terms of Use



**Effective Date: June 7, 2023**

## Introduction

These Terms of Use (“Terms”) constitute a legally binding agreement between you and Mercedes-Benz USA, LLC, its affiliates, and subsidiaries (collectively “MBUSA”) setting forth MBUSA’s obligations to you, and your obligations to MBUSA in relation to your access and use of MBUSA’s StarRewards website (“Site”).

These Terms, our Privacy Statement, and any additional terms you have agreed to by using specific components of the MBUSA Site (e.g. online account registration), make up the entire agreement between you and MBUSA related to your use of the MBUSA Site. These Terms do not alter the terms of any other agreement you may have with us unrelated to your use of the MBUSA Site.

By accessing and using the MBUSA Site, you affirm that you are at least 18 years old or have parental or guardian permission to use the MBUSA Site and that you are fully competent to enter into this agreement with MBUSA. You further agree that you will not use the MBUSA Site for any unlawful or fraudulent purpose or in any manner inconsistent with these Terms.
